- **Additional Cleanup Crew: \$371.88** – Log Country Cove Banquet Staff to clean up during and after event.
- **Rental Items through LCC:** - Any additional items rented through LCC, lanterns, cedar arch, terrariums, outdoor wood bar, champagne tower will be an additional cost.

To Reserve Venue: Full payment is required to reserve Cedar Skies. Full amount will be lost if ANY cancellation occurs. No Exceptions. If we can rebook the venue for your cancelled dates, 50% of full payment will be refunded.

Rules and Regulations for Cedar Skies and Log Country Cove Cabin Rentals

1. Rental starts at 11:00AM and ends at 11:00PM.
2. Clean up and out of Cedar Skies at midnight. No Later. No Exceptions.
3. Cedar Skies must be left in the same shape as you found it. You must remove all décor, trash, and anything brought in by wedding party/guest.
4. No decorations can be nailed, stapled, taped, tacked, glued or hung. All décor needs to be approved by LCC staff ahead of time.
5. Any damage done to Cedar Skies will be charged to responsible party.
6. Liability insurance must be purchased. (\$1,500,000.00 minimum)
7. If any alcohol is served, you are required to hire TABC Certified Bar Tenders through Cedar Skies. This applies for beer and wine also. **NO KEGS ALLOWED.**
8. All Vendors must be approved by LCC Staff and insured. Proof of insurance is required.
9. The caterer and bartenders are responsible for bussing tables, removing trash, cleaning up spills on the floor and the kitchen. All trash must be deposited in our on-site dumpster.
10. The client is responsible for removing all personal belongings, trash in the respective venue's bride and groom quarters and leaving the facility in good condition.
11. Reception and Music must be indoors.
12. No after parties will be held at any Log Country Cove cabins. Noise and party will be over at 11pm. No Exceptions.
13. No Smoking allowed indoors. We will have designated smoking areas. All cigarette butts must be thrown away in trash. No Littering. Any extra clean-up of grounds due to trash or damaged will be charged to responsible party.
14. We are a family friendly environment. Any guest or parties that get out of control will be shut down early.
15. LCC Staff is responsible for set up/tear down of chairs and tables only. Any additional clean up after wedding will be charged accordingly. No Exceptions.
16. The 12-hour time limit includes set up and tear down. If you need additional time, it will be \$300/hour additional.
17. If paying by credit card, there will be an additional 3% charge added to the price of venue, day of coordination and any other expenses run through Log Country Cove.
18. In the event of any obligation of either party is prevented or delayed by circumstances of natural disaster or act of God, such party will be excused from any failure to perform any such obligation under this agreement to the extent that such failure is caused by any such circumstances.
